If the participant(s) do not have a YMCA membership, you are required to purchase one. We offer two kinds to suit your family needs:

- A Family Facility Membership allows you full access to the facility, group exercise classes, pool, weight and cardio room, KidsZone, and 50% off most programs. If you're interested in enrolling in a Family Facility Membership, it's best to register at the facility so we can discuss your membership. Payments are monthly.
- A Program Membership is a yearly membership which allows you to participate in all our programs, however; no facility use. \$90/family for a year. If you currently have a Program Membership, you are eligible to upgrade to a Family Facility Membership with no enrollment fee.

The YMCA Y-Guides/Princesses program is heavily based on rituals and traditions that bring the sense of continuity, community, intrigue and magic to the program. The program today centers on the following aims for both parent and child:

RESPONSIBILITY

In joining the Y-Guides/Princess program I agree to uphold the aims of the program and place in high regard my responsibility as a parent and as a role model for all youth in the program. I will supervise my child(ren) at all events, be respectful of all rules and regulations set forth for facilities used by our program, and at all times set an example consistent with the YMCA purpose and mission.

CODE OF BEHAVIOR

As a member of the YMCA Y-Guides/Princess program, I agree to uphold the YMCA of Orange County Y-Guide/Princess programs standards. I agree to not bring or consume alcoholic beverages or illegal drugs at any YMCA sponsored event. I understand that if I am found in violation of this policy, I may be asked to leave the program immediately and forfeit any monies paid.

REFUNDS

Program fees include the Registration Fee and Program Membership Fee. Refunds are prorated based on the cancellation date and the end of the program term.

Event Fees include all fees paid at the time of registration for a specific event. Some events have a clearly stated no refund policy. In all other situations the YMCA requires to be notified by the registration deadline date to process a refund. Notification must be made to the Program Director by email, mail or phone call.

HEALTH STATEMENT

I hereby certify my children and I are in normal health and capable of safe participation in the YMCA Y-Guide/Princess programs. I assume all risks and hazards incidentals to the conduct of this program and for the transportation to and from activities. I hereby authorize the YMCA to obtain medical treatment for my child in the event that I cannot be reached. Additional, if I do not accompany my child on an outing, I will send a written note of authorization of medical treatment with the guardian of my child. If my child has any known health problems/conditions or allergies the YMCA staff should know about, I will fill out a record of health form for the YMCA to keep on file.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE YMCA FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO OBSERVATION, USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY OFF-SITE PROGRAM AFFILIATED WITH THE YMCA, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND CONVENANTS NOT TO SUE the YMCA, its directors, officers, employees, and agents (hereinafter referred to as "releases") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused the premises or any facilities or equipment therein or participants in any program affiliated with the YMCA.
2. THE UNDERSIGNED HEREBY AGREES TO IDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage or cost they may incur due to the presence of the undersigned in, upon or about the YMCA premises or in any way observing or using any facilities or equipment of the YMCA or participating in any program affiliated with the YMCA whether caused by the negligence of the releases or otherwise.
3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OR BODILY INJURY, DEATHER OR PROPERTY DAMAGE due to the negligence of releasee or otherwise while in, about or upon premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA.

THE UINDERSIGNED further expressly agrees that the foregoing RELEASE, WAIVER, AND IDEMNINTY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the state of California and that is any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
